HPREC President's Message By Bernard Bruand

COVID-19 is still with us and may be for quite some time. Wear your mask. Stay safe. Hope all is well with all of you and not too many members have been infected, otherwise recovered well.

All in-person activities of the Club are in suspend-mode, except for the Club meetings; Board of Director monthly meetings and the Tech Team meetings, all held by teleconferences. Hiking activities will be case by case; look for an email from the Hiking coordinator when they resume.

We are starting to prepare for the **Holiday Luncheon**, to be ready in case it can happen if the COVID-19 situation improves. We are not very optimistic it can happen, but we are looking into it.

However, there was a good side effect to the lockdown. Four members of the Tech Team have worked hard the last two months to develop a **new IT platform for the Club**. This platform will replace our 17-year-old membership management system that needed. replacing. It will integrate with the Club's website into one interactive solution, giving you, our members, immediate access to Renewal, Event bookings, Payments, Profile info, such as address and email. You will have real time access to all needed information, like: Did I book Holiday Luncheon? When? How did I pay? Online Member Directory updates in real time and more improvements.

The system will also enable us to introduce **fairer two-tier membership pricing** as some members have been requesting: 1) online access including online newsletter, and 2) online access with mailed printed newsletter. Members will receive the annual printed Member Directory mailed to your home address <u>if you Opt-in</u> to receive one during the registration process. The Board has decided to price tier 1 **online only at \$15 for next year**. The price for tier 2 for members to receive the **newsletter by mail at their address** will be determined at the Aug 5 Board meeting, considering the cost to print and mail the bi-monthly newsletter.

The Board's long-term objectives remain to encourage members to move toward online and to reduce volunteer time. We understand some members still prefer paper and don't use many online services, if any. We will keep available the option to pay by check and get printed newsletters for members who are currently engaged this way. If you can use online services, please do, especially for paying membership fees or booking events, as this reduces manual work for our volunteers (Online payments and event confirmations are fully automated with the new system). **Please do not submit any checks in advance of receiving a new system registration form in early October to complete and send in with a check**, if you did not register online before. There will be new data in the database, so the Registration form is <u>necessary</u> to process a check.

Speaking of **Events management** (reservation, payments), **I want to give a special thank you to Fran Low** who has managed this activity for many years and has decided it's time to pass it to someone else. Thanks, Fran for this long-term contribution to the Club!

Steve Mar has volunteered to take Fran's place - thanks Steve. He is also working with Darlene Cano to administer membership activities. It's critical that the new system reduces the workload on these volunteers and that as many members as possible work online, so that the manual work for Joins, Renewals, Rejoins, Events management is reduced. Otherwise, volunteers will be overloaded. (Members volunteering for Club operational activities have dropped off in recent years.)

Please take a look at the Tech Team article in this issue with more details on the new system.

Nominations for the Board: we are looking for members willing to contribute and join the Board of Directors. Please contact me or Oscar if you can contribute and help manage the Club.

Tech Team Update – New IT Platform for the Club

What Are We Doing and Why?

While under "stay at home" orders due to the Coronavirus pandemic, mostly a subteam of the **Tech Team** has been very busy meeting virtually and working from home on evaluating and testing alternative platforms for both our membership database and website offerings. This has been necessary due to:



- declining volunteerism and relieving current volunteers who've been at it for quite some time
- the need to move from a no-longer-supportable platform that is 17 years old and needs replacing
- and equally important, looking for ways to offer <u>improved</u> and <u>additional</u> features for our members. *A win-win!*

Not long after, the four-person sub-team had a working prototype. The Tech Team members tested the prototype and shared feedback; adjustments and improvements were made. The new platform option was demonstrated at the June Board meeting with great questions and discussion. By the meeting's end, the Board approved the new option and plans.

What Changes Are Coming?

- 1. The new comprehensive and secure Membership system will allow you to:
 - manage your own profile data
 - manage your membership renewal and pay online via Stripe our current payment provider
 - sign up for events and pay online via Stripe
 - access content from the annual Member Directory:
 - Board of Directors, Club Contacts, Club Volunteers
 - Website Intro, including Passwords for various websites
 - o Company Contact info: HP Inc., HPE, Agilent and Keysight
 - o Online Directory real-time and again, secure, and based on member's preferences

- 2. To access this new comprehensive and secure Membership system, you will need to register with a Username and Password. Tips on getting started will be available in the September newsletter.
- 3. As highlighted in the President's message, **two-tier membership pricing** will go into effect. You will need to select which option you will want once you're signed in:
 - a) online access including online newsletter at **\$15 for next year**
 - b) online access with mailed printed newsletter price to be determined at August Board meeting taking into account the cost to print and mail the bi-monthly newsletter
 Both tiers include the printed annual Member Directory mailed to home address, <u>if the opt-in option is chosen</u>. Two tiers of dues were established to recognize the increased cost of providing paper newsletters mailed to your home, which we are still willing to do.

We encourage all members to set themselves up online and engage with the Club online including online newsletters. We can offer a detailed tutorial on what to do (voluntary). *Let us know if you wish to receive some help beyond the "Tips" we've created for the website, to be provided in the September newsletter issue and email to be sent.*

We will continue to support members who are not comfortable with online participation. You will be provided with a paper New System Registration Form, paper renewal and paper Event registration. Our Membership Admin team of Darlene Cano and Steve Mar will assist with loading and maintaining your information and Event sign-ups as you submit them.

When Will This Happen? The new platform will become live with the upcoming renewal season that will start Sep 1.

<u>*What's Next?*</u> More detailed information to come in the September newsletter about what's changing, what's staying the same, and how you can stay involved in helping us with a much-needed transition.

Current Plans:

- 1. Tech Team (TT) will transition to the new platform in July-August to be ready for the upcoming renewal cycle. We will retain the online payment provider Stripe that we transitioned to last year no change here. Please pay online to save work for our volunteers, and you will immediately know that you have renewed.
- 2. Beginning this year, the Membership Renewal drive will begin Sep 1 and end Nov 30.
 - a) Sep 1-30 will be open for online renewals only.
 - b) Oct 1-Nov 30 will be open for online and paper renewals.
 - c) Please do not submit any checks in advance of receiving a New System Registration Form in early October for you to complete and send in with your check.
 Note: If you have not renewed by Nov 30, you will lose access to HPREC services until you renew.
- 3. On **Sep 1**, members with an email address on file will be sent an email message to begin renewing online. *Note:* If we don't have your email address and you wish to receive the Sep 1 email message, please go to our website <u>hpretirees.org/hprec</u>, click on **Member Info Updates**, and provide your email address no later than Aug 15. Current access code for this web page can be found in your Member Directory.
- 4. Any member who has not renewed by Sep 30 will receive a paper invoice and a New System Registration Form in the mail around Oct 10. Online renewal is strongly encouraged.
- 5. You will need to <u>create your own username and password</u> to allow you access to the system for renewal and updates, to the newsletters (to be protected from public searches), and the new secure online directory. Make sure you JOT DOWN your username (cannot change in system once you choose it) and password (can update whenever you want) as the Club will <u>not</u> have this information. Tips on how to select a username and a strong password will appear in September's newsletter. (Continued...)

- 6. The benefits of the new comprehensive and secure Membership system are:
 - a) allow you to look up your payment information for Club renewal and events to avoid double payments
 - allow you to view other members' contact info (per each member's preferences). We will continue sending an annual printed Member Directory for members who opt-in to receiving one vs accessing the directory online. We encourage you to save trees!
 - c) two membership options are available:
 - 1) online access including online newsletter at **\$15 per year**
 - 2) online access with mailed printed newsletter price to be determined at Aug Board meeting taking in to account the cost to print and mail the bi-monthly newsletter

Note: Double payments will <u>no longer</u> be refunded, rather another year will be added to your membership.

- d) drastically reduce manual data entry on the part of our Membership Admin team for membership and event sign ups
- e) capability to allow for additional activity sign-ups, such as volunteer events, hiking, travel, as activity leads need more timely information vs bi-monthly newsletters
- f) better integration of bi-monthly newsletter event notices with online Calendars of Events.
- 7. As for the annual email Board of Director Voting process, it will take place Sep 3-30. An email will be sent to all members with an email address on file by Sep 3. See *Note* in #3 above, if you'd like to provide your email address to participate.

We invite you to support and embrace these changes, as we were looking for new features and flexibility members might enjoy, while also replacing an aging system and easing the manual administrative load for the volunteers who work hard to keep you informed and engaged.

ID Theft and Digital Fraud Protection

One of the greatest financial risks to Seniors today is not market volatility or investment performance, but ID theft and fraud targeted specifically at Seniors. After working at HP and Agilent, I joined the First Tech Credit Union (Addison Avenue before the merger) as Director of Risk Management.

I saw several difficult fraud cases impacting our members. This will be the <u>first of a series of articles</u> in the newsletter offering information



on how these frauds work, and suggestions on how to avoid becoming a victim. If readers have specific questions or ideas for future articles, please share them via the HPREC email addresses.

Twenty years ago, paper documents in the trash were a leading cause of ID theft, and shredder sales took off as people exercised more care about items discarded. In addition, regulations limited information like account numbers on monthly bills and credit card receipts, so losses due to ID theft from paper in the wrong hands has diminished greatly. Shredding is still a good idea, but the fraudsters have moved into automated tools.

Today, the vast majority of financial fraud and ID theft occurs through two electronic channels: personal computers/tablets and smart or home telephones. Each have a set of vulnerabilities and many Seniors either fail to take all the precautions they should, or are tricked into revealing information that thieves (often outside the U.S.) can use to steal funds from bank or investment accounts, or take loans in the name of the victim(s) that the victims are liable for. Email scams steal close to \$2 billion each year in the U.S., and telephone scams (impacting 1 in 10 Americans each year) are reported to steal close to \$10 billion annually.



The primary risk with computers (desktops/laptops or tablets) is phishing emails, where the sender or subject matter is disguised to look legitimate, and the message is intended to trigger the victim to call a number or log into a website or click a link that will expose their private personal financial information. Examples might be an email appearing to come from your bank or the IRS or a lottery or contest you didn't enter, urging you to call or click or "log in" to resolve a problem. Often these may seem

threatening ("Your account will be frozen!") or very tempting ("You have won \$500,000!). Sadly, many tablets show only the spoofed sender name, and not the real address of the sender, which might include a domain name outside the U.S.. Once you click on a suspicious link, or log into a fraudster website, you should assume all of that account information is compromised.

In addition, most desktops and laptops are also subject to a virus download so that every log-in attempt you make after the initial fraud site is recorded and sent to the fraudster without your knowledge. The only solution is to be highly suspicious of ANY email you receive, including even friends' message such as "Hey – check this out.". Those are often sent when an email account has been compromised. Just delete the message, or call the sender using your own contact numbers, and delete if at all suspicious.

Telephones are channels for fraud either by gaining access to smart phones with apps like online banking, account passwords, etc., or through calls from fraudsters hoping to trigger a response that gives them access to your information. If you have a smart phone and it doesn't have at least a four-digit (random!) security code, set that up immediately! (And no -1-2-3-4 is not secure!) Thirty MILLION smart phones are lost or stolen in the U.S. each year, and if yours is not secure and goes missing, EVERYTHING on it is potentially in the hands of a thief. The second risk for telephones is the spoofed call that appears to be from the IRS or sheriff or even the kidnapper of a grandchild. Those demand action like providing log-in and password, or sending a "gift card" or threats of arrest and jail.

With the benefit of Caller ID and voicemail or even traditional answering machines, you should never answer a telephone call today unless you are sure you know who the caller is. Just let it go to voicemail or "the machine" and either pick up if you recognize the caller, delete the message or call back. We typically receive a couple of fraud calls per day between our cell phones and landlines and generally refuse to answer calls from "toll-free caller" or "out-of-area" callers. Remember, there is no rule or law that says you must answer the phone just because someone else has chosen to disturb you. And, if you were



wondering, the federal "Do Not Call" list is worthless since Congress and law enforcement have not found an effective way to enforce the law. Neither have they found a way to force callers to accurately display their number.

To recap, ANY phone call claiming to be from Microsoft to help you "fix" your computer, or from the IRS or Sheriff or Immigration or in Mandarin is a fraud, and should simply be ignored. The same is true for any call claiming you won a contest, or that your account is locked or frozen. If you think there is a chance of a banking problem, again, call your bank or credit union on their regular customer service line, and not the phone number left in the recording. You could report fraud calls to the FTC if you had extra free time, but they won't actually do anything about them. Seniors also need to know that once money is gone from your account, it is very rare to recover the funds. Wire transfers can't be reversed, and those responsible are rarely caught.

I hope all our members can learn to be suspicious always, and resist the temptation to click on a link, or respond to an email that is part of a fraud scheme. And when your smart phone or landline rings with an unrecognized number, remember it is your absolute right to let the call go unanswered or roll to voicemail or the answering machine. From there, you can carefully decide whether to take further action or simply delete the message and let the fraudster cheat someone else. Remember, telephone fraud is so common because it works! The cost to make 1 million Robocalls is trivial, and even a 1/100th of a percent success rate means stealing money from hundreds of victims.



Paul Eugene Stoft, May 28, 1922 – June 1, 2020

Born in Pittsburg, Kansas, Paul was the son of a minster who moved the family to Pennsylvania when Paul was 3 months old, then moved the family back to Kansas during the dust bowl, then on to Denver where Paul attended high school. Paul earned his BSEE from University of Colorado, served 2 years in the Navy at the end of WWII, and after his discharge, returned to Denver and married Dorothy Jones whom he had met at age 13. The couple spent the next ten years in Boston where Paul taught undergraduate courses at MIT while completing his doctorate in electrical engineering. They then moved to California where Paul worked briefly for General Electric before accepting a position at Hewlett-Packard in Palo Alto in 1958.

Paul began work in the R&D labs that reported to Barney Oliver, and with little more than a year on the job, he was promoted to one of the labs' four management positions. When the labs were reorganized, he became manager of a section of Barney Oliver's Advanced HP Labs which explored new product ideas and technologies and brought them to fruition. Paul described his lab as magical, a place filled with creative geniuses. Of the many projects his lab developed, perhaps the most significant was the HP 9100A desktop computer. It was a groundbreaking success, but Bill Hewlett wanted something even better: all the computing power of the 9100A squeezed into a pocket-size device. Paul's lab did just that, and developed the HP-35 hand-held, scientific calculator. Paul's other notable contribution during his decades at HP was his push to move to MOS technology and build a new facility to work on IC research and design. It was in that new facility on Deer Creek Road where Paul finished out his career at HP.

Apart from work, Paul, and his wife Dorothy, who passed away in 2002, touched many lives through their mentoring of young people and their generous charitable contributions.

Paul passed away peacefully at age 98. He is survived by his three children, Steven Stoft of Berkeley, CA, David Stoft of Menlo Park, CA, and Judy Stoft of Albuquerque, NM, and by a grandson, Gregory Stoft.
